Notice of adjustment to the Exchange Property

Capitalised terms that are not defined in this notice shall have the meanings given to them in the terms and conditions of the Bonds (the "Conditions").

In accordance with the Conditions, AB Industrivärden (publ) ("AB Industrivärden", or the "Issuer") hereby gives notice to Bondholders that, as a result of the Cash Dividend of SEK 10.00 per ICA Gruppen Share paid on 27 April 2016 constituting a Capital Distribution (of an amount determined in accordance with the Conditions), the Exchange Property has been adjusted in accordance with Conditions 8(b) and 8(e) to comprise 14,848,020.07 ICA Gruppen Shares, effective 19 May 2016.

Following such change the *pro rata* share of the Exchange Property to which the holder of SEK 1,000,000 principal amount of Bonds would be entitled upon exercise of the Exchange Right in respect of such Bond comprises 3,374.5500 ICA Gruppen Shares.
