## Communiqué from Industrivärden's 2018 Annual General Meeting

Industrivärden's Annual General Meeting was held on April 17, 2018, at the Grand Hôtel in Stockholm, at which the following resolutions were made, among other things.

- The Annual General Meeting set the dividend at SEK 5.50 per share (5.25). The record date for payment
  of the dividend was set at April 19, 2018. Dividends are expected to be paid out via Euroclear Sweden
  AB on April 24, 2018.
- Pär Boman, Christian Caspar, Bengt Kjell, Nina Linander, Fredrik Lundberg, Annika Lundius and Lars Pettersson and Helena Stjernholm were re-elected as directors on Industrivärden's board. Fredrik Lundberg was re-elected as Chairman of the Board.
- The Annual General Meeting resolved to re-elect PricewaterhouseCoopers AB as auditing firm.
- The Annual General Meeting voted in favor of the Board's proposal for a long-term share savings program for employees of Industrivärden. The share savings program makes up the form of long-term variable salary and corresponds to the program approved by the 2017 Annual General Meeting.
